Evergreen's Public Involvement Activities To Date

- Updated the **2006 Public Involvement Plan** (PIP) in 2019, and later the **Community Outreach Plan** as an amendment to the PIP based on community feedback
- Created **Evergreen website**, which went live July 2019, to provide access to all Act 2 reports and provide updated information to the community
- **Attempted Public Meeting** in November 2019
 - Evergreen has been accepting public comments and providing answers since the time of the attempted meeting – a total of **14 months of public comments** are published on the website
- **Small group meetings** with community representatives throughout late 2019 and in 2020
- Created an **email distribution list**, which is updated continuously, for regular notices/eblasts
- Sent out a **hard copy mailer** to all residents within 1 mile of the site in June 2020
- Created **plain language summaries** and **translation** of the summaries on the website
- Held **Public Information Session** in August 2020 to provide overview of the RIRs
 - The U.S. EPA also hired a contractor to provide the community with a summary of the RIRs and presentation, which was completed in August 2020
- Received and responded to **over 1,000 comments** on the RIRs

Next Steps

- Prepare a **summary of all comments and answers** received by Jan. 14, 2021 (Public Comment RIR), which is to be reviewed by the PADEP
- **Public meeting** with City/DEP/EPA on February 18.
- Increase frequency of **small group meetings**
 - Next scheduled meeting is Jan. 28 with Philly Thrive
- Hold **quarterly public meetings** to discuss specific topics (as requested by public) related to forthcoming reports
- Participate in **existing Community Advisory Panel (CAP)**
- Continue **responding to Q&A** for ongoing Act 2 activities and post on Evergreen website
- Continue **email communications**
- Continue **plain language summaries and translations**
- Submit **AOI 4 and AOI 9 Addendums** in Q1 and Q3 2021
- Submit **Fate and Transport RIR** in Q4 2021
- Add **general updates and schedule of activities** to website


